Notes/Narrative**PC STATEMENT/SUMMARY:**

An individual went inside the locked residence of the victim, smoked a cigarette, and left the cigarette butt in the sink. Victim believes it is a message meant to intimidate him, and continued harassment from an individual from a previous case.

SOURCE OF ACTIVITY:

On 9/16/2018 at approximately 1628, the victim contacted 911 to report the incident.

INVESTIGATION:

I contacted the Reporting Party / Victim, Moriwaki, Clarence B., at his residence at 155 Madison Ave at approximately 1815.

Clarence explained that he had left his house earlier in the day to attend a wedding. He stated that both his main entrance and balcony entrance were locked when he left. When he returned home a little after 1400, he immediately smelled the strong odor of cigarette smoke in his residence. At first, he thought it must have been smoke from someone smoking outside at Winslow Green.

A short time later Clarence went to his kitchen sink to put away clean dishes drying in the sink from coffee earlier in the morning. He noticed that the dishes were all wet, which he found odd since they had been drying all morning. It was at this point that he noticed a wet cigarette butt sitting in the sink drain. That is when Clarence realized that somebody had entered his residence, smoked a cigarette and extinguished the cigarette in his sink.

Clarence immediately began to check his residence for missing property, but nothing was missing. His laptop computer was sitting opened, as he left it, on the dining room table a few feet from the sink. There was also an uncashed check sitting on the counter as well. Clarence went through his entire residence but could not find anything missing, nor any more evidence of the suspect.

Clarence stated his belief that the cigarette was deliberately left there as a message to him from Richard Rynearson, whom Clarence has been stalked and harassed by in the past (reference I17-000145).

Clarence's neighbors, Tom Moench and Jennie Clyne, had been moving out of their residence (the apartment immediately next to Clarence's and sharing a stairway). They had been in and out of the apartment all day, except when they left to eat lunch between approximately 1230 and 1345. Clarence had returned to his residence not long after the neighbors had returned from lunch. It is likely that Clarence's residence was entered sometime between 1230 and 1400 when the neighbors were out, otherwise they would have likely since anyone entering his place.

Another neighbor downstairs in 151 Madison Ave, Joan A. Jensen, had a carpenter working in her garage all day



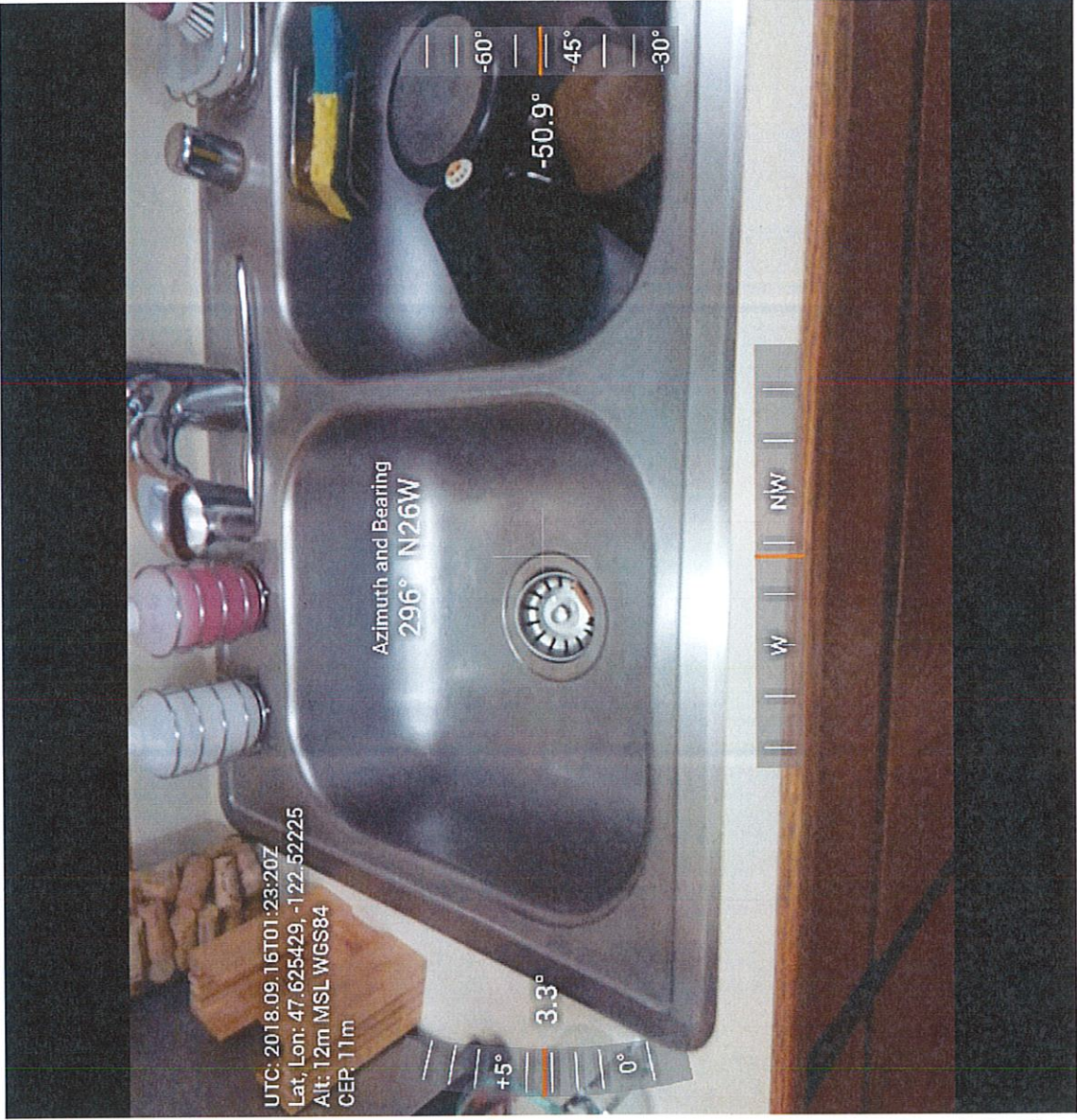

Results and Conclusions

The lift cards contain four impressions suitable for comparison that were marked P-1 through P-4. These impressions are correlated to the respective lifts in the evidence list. Upon further examination, P-4 was voided due to the lack of clear ridge detail.

P-1, P-2, and P-3 were identified as the left ring, right index, and right middle fingers of Clarence Moriwaki (D.O.B. 11/08/55).



The eight submitted lift cards were analyzed by the undersigned for latent prints. P-1 through P-4 were compared to the submitted exemplars.

Identification is the opinion of an examiner that there is sufficient quality and quantity of detail in agreement to conclude that two impressions originated from the same source.
