

**Statement for Petition for a Permanent Order for Protection from Harassment and Stalking
and Request for an Immediate Surrender of Weapons**

I am deeply grateful to the court for granting the Temporary Protection Order of Harassment and Stalking against Richard Lee Ryneerson III a.k.a. Rick Ryneerson/Richard Lee on March 13, 2017, and I am seeking relief that it continues as a Permanent Order.

Along with my original statement dated March 10, 2017, I am adding to the record additional evidence which reinforces and sustains this court's correct decision for a Protection Order, documentation of which proves that for years Ryneerson has been, and continues to be, a serial cyber stalker and compulsive internet troll. I just happen to be his latest target and victim.

Moreover, upon doing research into Ryneerson's documented history of cyberstalking and internet trolling, I have discovered scores of legal and military records, along with comments about and by Ryneerson himself, that have left me gravely alarmed.

I am fearful and overwrought due to his documented history of anger; official reports about his aggressive behavior and abysmal judgment; contempt of law enforcement; disdain and disregard of the courts, authority and the feelings and wishes of others; unrepentant bravado for killing people; premeditated actions for the use of force to intentionally cause harm; and his provocative passion and activism for the unlimited use of and unpermitted concealment of firearms.

In light of these clearly demonstrable factors, I am seeking additional relief from the court to Order an Immediate Surrender of Weapons.

Additional Documentation for a Permanent Order for Protection of Harassment and Stalking

I am private citizen and not an elected official nor public figure, nor am I Richard Lee Ryneerson III's first victim of cyberstalking, harassment and internet trolling. For years he has been obsessively and compulsively trolling, hijacking and stalking web sites, blogs, Facebook pages and people. Many of these victims have blocked, banned and made it patently clear to Ryneerson – sometimes on multiple occasions – that they did not want any further contact from him.

Rynearson concealed his real identity from me, trolling and hiding behind the Facebook identity of “Richard Lee.” I also suspect that Rynearson may have also used his wife’s name Hyland Hunt as a fake identity Facebook page, of which I concluded after “Hyland Hunt” failed to reply to a direct private message from me when I challenged her/his identity. (“Statement for Petition for an Order of Protection and Harassment and Stalking,” March 10, 2017)

It appears that Rynearson created the fake Facebook identity of “Richard Lee” on or about December 15, 2016, and it appears that a Facebook identity with his wife’s name “Hyland Hunt” was created on or about December 16, 2016. (List of “Admins” and “Moderators,” WWII Japanese American Internment Facebook page)

Rynearson created the Facebook page “WWIII Japanese American Internment” on October 27, 2016, and about a month-and-a-half later, he bizarrely joined his own page as a moderator on December 15, 2016, posing as “Richard Lee.” The next day, the Facebook profile with his wife’s name “Hyland Hunt” joined the page as an administrator on December 16, 2016. Since this page is supposedly administered by the husband and wife team of Rynearson and Hunt, it is suspicious that “Hyland Hunt” was not an administrator from day one, but only joined the day after “Richard Lee” was added as a moderator. I accepted a friend request from “Richard Lee” on December 20, 2016, and he sent me a text message on the same day. (List of “Admins” and “Moderators,” WWII Japanese American Internment Facebook page; “Richard Lee” Facebook private message, 11-20-2016, 4:46 p.m.)

Among Rynearson’s many other on-line “hidden” identities and pages, the ones that I have been able to confirm are PickYourBattles.Net www.pickyourbattles.net or “PYB”; Veterans Against Police Abuse <http://www.veteransagainstopoliceabuse.org/> or “VAPA”; Martial Matters <https://www.facebook.com/PYBMartialMatters> (note that Rynearson ties the “PYB” with the page address), and the WWII Japanese American Internment Facebook page <https://www.facebook.com/groups/WorldWar3Internment/>; “WingedRyno” and “VAPARick.”

As seen by these examples, Rynearson has an on-line record of creating and assuming multiple identities, web sites and blogs. He is not only attempting to mask his true identity for stealth opportunities to cyberstalk, but as he vainly tries to gain credibility, validity or “likes” for his opinions and causes, Rynearson endeavors to create the faux appearance of more individuals participating on his web site/blog/Facebook pages/comment threads by having conversations amongst himself, using his multiple identities and websites to comment and link to each other. (“WWIII Japanese American Internment Facebook page,” February 6-20, 2017)

Rynearson has been trolling me for at least a year-and-a-half, with the first known instance of his trolling was about six months before he moved to Bainbridge Island. On November 7, 2015 he posted a Vimeo podcast featuring me on the timeline of his Facebook page “Martial Matters,” and his first share of one of my own Facebook posts was on December 13, 2016. (Martial Matters Facebook Page, November 7, 2015, December 13, 2016; Clarence Moriwaki Facebook Page, Dec. 11, 2015; Richard Lee Facebook message, 11/20/2016 4:46 PM)

Rynearson also paid for Facebook ads to promote his “Not Clarence Moriwaki of Bainbridge Island” Facebook page (which may have started at least in early March, 2017 and run for at least a week) forcing his cyberstalking and harassment towards me into the mass public sphere of Facebook users on both their pages and mobile devices “...he may have paid for the ad a week ago and asked it to run for a certain number of days. I feel like I have seen it for about a week.” (“Rynearson paid for Facebook ads to increase cyberstalking and harassing me, Pages One and Two,” Clarence Moriwaki Facebook page, March 15, 2017)

Long record of serial cyberstalking, internet trolling, and being blocked and banned

While still in active duty with the US Air Force, Rynearson was officially reprimanded for lying about posting USAF material to his own website “PickYourBattles.Net”:

“...on 1 October 2009, you discussed a possible publication in the Air Force Times...When asked if you had posted any material that may be of interest to the Air Force Times on any blog or public website, you stated “no.” It was only after repeated inquiries did you finally state that there “may be” information available to the Air Force Times on the internet. Your initial denials of your internet postings to the Public Affairs staff were deceptive and false.” (MEMORANDUM FOR MAJOR RICHARD L. RYNEARSON – SUBJECT: Letter of Reprimand, USAF, October 27, 2009)

Rynearson has been cyber stalking, hijacking websites and harassing to the point of creating an infamous reputation for being blocked, banned and removed from numerous websites and blogs. In one instance, on July 30, 2012, Rynearson became a member of the internet blog site “GLOCK TALK – THE LEADING FIREARMS FORUM” and less than a day later, after relentlessly posting around 100 argumentative and belittling messages and responses, the creator and moderator of the site demanded that Rynearson, posting as “VAPA-Rick,” leave:

“PLEASE READ THIS VAPA You’re clearly I violation of this (website’s standards and rules), so could you please do everyone a favor and just piss off. Go polish your psycho-wagon and just leave us alone. You’re not interested in hearing opinions or learning anything. Go make your fortune while you still know everything. But do it away from here. You’ve worn out your novelty...Please just stop. You’re making an ass of yourself...

*...Folks, I did not create this forum...to question the morality or legality of (law enforcement) practices. You (Rynearson) might have a burning need to do so, but this is not the place to do it... I want you gone. You don’t want a dialogue – dialogues go two ways. You’re just *****ing. You’re an obvious troll who is just looking for attention. Please, do leave, and please honor the rules of this thread (which you have not surprisingly ignored up to this point completely) if you should decide to stay.” (GLOCK TALK – COP TALK, July 31, 2012, post #120, #127, #131)*

(VAPA-Rick) *“Ah yes, troll” the most overly used word on the internet. Definition being, “somebody who hands me my ass on the internet, and makes me “oh so mad” that I can’t intelligently respond!” (GLOCK TALK – COP TALK, July 31, 2012, post #135)*

Another website where Ryneerson overstayed his welcome was the popular “John Q. Public” blog site and Facebook page, both created and administered by retired US Air Force Lt. Col. Tony Carr. Tony Carr’s Facebook page has more than 45,000 likes and this plus his web blog site has enjoyed more than 1.1 million annual visitors. Out of all of his followers, Ryneerson was one of only two people of whom Tony Carr has ever removed and banned from his blog and Facebook page:

“Looks like PYB (Ryneerson “Pick Your Battles”) just got banned from John Q. Public’s pages. Seems to be a trend for him...Quote: “After the posting of some inappropriate comments, a handful of complaints, and a failed remediation campaign, I’ve banned Rick Ryneerson from posting here. This is just to reassure those of you who had concerns. It takes an awful lot to get banned from anything I’m administering. I promise you it wasn’t done lightly in this case.” (“Tony Carr’s latest John Q. Public blog post,” Flying Squadron.com web blog, March 16, 2014)

“...Do you even know one of (Ryneerson’s) eleven anonymous handles? He’s been banned (from the John Q. Public web blog site) for a while...Two people banned (from) about 1.1 million visitors...” (“Service Culture, You’re Doing It Wrong,” John Q. Public web blog site, October 22, 2014)

“(Ryneerson’s) kind of conduct that you describe...is why I don’t associate with the guy anymore. He is incapable of reasonable disagreement and attacks on personal grounds constantly, almost always without fact and in the most caustic terms possible.” (John Q. Public Facebook page, March 5, 2015 at 6:59 a.m.)

On March 17, 2014, one day after he was blocked and banned from the John Q. Public’s Facebook and webpages, Ryneerson launched his “Martial Matters” Facebook page, cyber stalking, harassing and targeting Tony Carr with the opening portent: *“Can a person be a character assassin, if his targets lack character? We will find out.”*

Nearly daily – often multiple times per day – Ryneerson would post comments and memes attacking Tony Carr on his blog and Facebook pages – precisely the exact same pattern of relentless cyberstalking and on-line harassment that Ryneerson did to me, when he created the “Clarence Moriwaki of Bainbridge Island” Facebook page on February 6, 2017, one day after I blocked him on February 5, 2017. (Martial Matters Facebook Page, March 17, 2014; “Statement for Petition for an Order of Protection and Harassment and Stalking,” March 10, 2017)

After being banned for years from the John Q. Public blog, on July 5, 2016, Ryneerson unwelcomingly resurfaced by trolling and commenting on a one-year old post, of which a screen shot was submitted with my March 10, 2017 statement. Among the many articulate comments and observations about Ryneerson’s behavior and method of operation were these:

“You (Rynearson) write entire articles and run entire pages impugning the character of private citizens based on their online comments in casual conversation. You do this not because you actually care about anything...but because you simply find it entertaining to harass people on line. This makes you petty and useless, which is how most people describe you these days when the name Rick Rynearson comes up...

...It's no mistake you get banned from basically every website that you frequent...it's not because everyone is a fascist or censor...you exist online purely to entrap, harass, defame and vilify others. There's nothing constructive or inspiring or even stimulating about that, which is why your efforts have failed to gain much of a following. That and your lack of credibility, which is a sign of serial dishonesty.

...If you had any principles, you'd contain your critiques to the facts you can observe rather than pretending knowledge you don't have...and pretending you're some kind of shaman of morality and patriotism. You lay claim to nothing more than personal opinion...and you advance it as poorly as anyone, attempting to support it with hate rather than evidence...Continuing to argue to the contrary because of some facebook (sic) exchange with (Tony Carr) years ago makes you look like an idiot. It also makes you look weirdly obsessed given that Tony (Carr) is a private citizen with zero direct influence on the government...

...Maybe at some point you'll admit what this is all about: you getting pissed off when people ban you from social media outlets after you make an ass of yourself in a way they're not willing to tolerate...you “pick your battles” rationally, opportunistically targeting and defaming people who don't have any official power.” (“One Commander's Independence Day Message,” John Q. Public blog site, July 3, 2015)

Rynearson was also banned from the website “FLYING SQUADRON FORUMS BY BASEOPS.NET,” a successful site which enjoys tens of millions of views, and apparently Rynearson is the ONLY person who has ever been banned from this site:

“...I've also been (moderating this website) over ten years and seen thousands of registered users, tens of thousands of posts and tens of millions of views. We've had only a few bad apples and only one turd (Rynearson) won't flush. Those aren't bad numbers. I don't mind playing the villain and indulging one lonely person's internet superhero fantasy...” (“Decline of Baseops.net (a.k.a. The Wrath of PYB/Mods gone wild) Comment by “gearpig,” FLYING SQUADRON FORUMS BY BASEOPS.NET, October 24, 2014)

“...Unfortunately, I think in this case, (Rynearson's behavior) goes a little beyond merely being a jackass or a simple lack of humility. No amount of reason can right the defect in his mind. This is a bona fide mental illness readily identifiable by virtually everyone but himself. He's used the exact same tactics of creating sock puppets at other forums and remains undaunted by the fact that virtually everyone immediately figures it out and gives the same reaction.

When people fail to agree with him and appreciate the person he is in his own mind, they become the enemy. His hateful fantasy of omnipotence is a direct result of narcissism met by a peer group that will not tolerate his delusions of grandeur. He's now wearing the title "Jesus" proudly and brags about it on his manifesto/blog. Wow...

Narcissists are incapable of humility which, by all accounts, he's never been able to function in a social setting. He's a full grown man churning out "meme" pictures on a daily basis like the kids at 4chan. He's been manipulating who knows how many alternate logins on several forums, many of which he's been banned from. He's been frantically searching my post history. I've watched him do it in fruitless effort to find something to dredge up from years ago.

I don't even have to do anything except watch the frustration and meltdown unfold in conversations with himself. Awesome and frightening. To those he's calling out by name, keep checking your six." ("Decline of Baseops.net (a.k.a. The Wrath of PYB/Mods gone wild)" Comment by "gearpig," FLYING SQUADRON FORUMS BY BASEOPS.NET, October 26, 2014)

Samples of Rynearson's angry, on-line vitriol

"...This is the point where I express a hearty, fuck you. You're an un-American cunt and while you will ban me...it doesn't matter...I'm out of this shit hole. I recommend others find another forum that is moderated not by Al Qaida, ISIS, Kim Jong Un, (page moderator) or any other free speech denying ideological twat." (Commenting as WingedRyno after being banned from "PhantomPilots.Com – Standard Propaganda Website," PickYourBattles.Net, Friday, December 18, 2015)

"Splash one fascist cowardly fuck...Morted. Buh bye. Pick Your Battles: Finally, Tony Carr Admits It And Proves His Fascist Cowardice..." (Martial Matters Facebook page, July 5, 2016)

"Tony (Carr) will drop the ban hammer here shortly and excuse it with whatever nonsense he pulls out of his ass...Words are too much for his thin insecure skin..." (Martial Matters Facebook page, July 5, 2016).

Rynearson wrote a long, rambling and angry rant after being blocked and banned from the FLYING SQUADRON FORUMS BY BASEOPS.NET web site, some short excerpts:

"...It's ironic how you dumbasses can't help but bring me up anytime your panties get in a wad. And you know who I am. You've done your homework. So you know you don't hold a candle to me. There is no measure of a man, on any scale, where you fuckstains come even close. And you hate that. I am the (Air Force) officer you could never dream of aspiring to be. This pisses you off. Because you, outside of your bullshit antics, are a coward catering to other cowards...Ban them all! Ban them!" (Posted after being banned from "FLYING SQUADRON FORUMS BY BASEOPS.NET," Martial Matters Facebook Page, October 23, 2014)

“...Good thing there are a few adults trying to tell you dipshits to knock off your stupid antics, to which you respond by beating your adolescent chests...Unlike others, I didn’t put my tail between my legs and suffer insults from that cocksucker. Instead, I owned his ass...Because your forum is all about cowards, behaving like cowards, who can’t man up...” (Posted after being banned from “FLYING SQUADRON FORUMS BY BASEOPS.NET,” Martial Matters Facebook Page, October 23, 2014)

Examples of cyber bullying and on-line harassment

Along with Ryneerson’s demonstrated cyber bullying, stalking and on-line harassment documented in my March 10, 2017 statement and also being blocked and banned from the web blogs and Facebook pages of “GLOCK TALK – COP TALK;” “John Q. Public;” and “FLYING SQUADRON FORUMS BY BASEOPS.NET;” “PhantomPilots.Com” and other websites and personal Facebook accounts, multiple individuals have drawn a line and demanded that Ryneerson stop his cyber bullying, on-line harassment and trolling. Ryneerson does not back down, respect nor comply and simply doubles down his harassment:

“...I’ve said everything that needs to be said and I will not alter one word to appease your ego. Last warning (Ryneerson), leave me be. We have nothing to talk about...” (Ryneerson responds):
“...As to your warning for me to stop...I’m going to have to think about that one. Okay, I’ve thought about it...I will express my opinions...despite your thinly veiled threat and warning. Thanks so much.” (Martial Matters, Facebook page, January 10, 2016)

A typical example of Ryneerson’s now well-honed and repeated cyber bullying tactics was when a former high school classmate posted on Facebook that she was offended when strangers swore in front of her three-year-old child in a public setting, of which Ryneerson vigorously defended as appropriate behavior *“...yes, saying fuck in front of a three year old (sic) is absolutely fine by me...”* and he then proceeded to mock her parenting. (“(high school classmate’s name) – Little Tyrant of Purdy, WA,” Pick Your Battles, August 13, 2014)

The high school classmate disagreed and after subsequently unfriending Ryneerson on Facebook, he turned to further harass and publicly shame her by bringing *“...up the topic on (his) own private Facebook page...(and then after many public comments he) made the thread public and sent (his high school friend) the link in case she wanted to join in.”* Ryneerson recounts and attempts to justify this cyber stalking and harassment incident by writing a full article on his web blog “Pick Your Battles” attacking her, and he posts this belittling and ironically contradictory comment of which was removed by Facebook:

“...Just got defriended by some dumb chick I went to high school with. She’s a little tyrant who thinks those in the public sphere should bow down to her and her idiotic viewpoint...#(high school classmate’s name) I did not “cyber bully” her.” (“(high school classmate’s name) – Little Tyrant of Purdy, WA,” Pick Your Battles, August 13, 2014)

Documentation of contempt for law, law enforcement, authority and the judicial system

While in the US Air Force, Ryneason was officially reprimanded multiple times, the first to my knowledge was for being arrested by law enforcement for a minor infraction, of which he escalated into larger issues due to his disregard for authority and his own self-aggrandizement:

“...on or about 7 September 2009 you were arrested by the San Antonio police department for a routine traffic stop. I found it disconcerting that the arresting officer cited your unwillingness to cooperate with his lawful requests and your aggressive behavior toward him as factors leading to your, otherwise unnecessary, arrest.

Equally disturbing was your post-arrest boastful taunting of the officer with statements “(I am) military and had fought in wars, and killed people” and “(you) had better watch out while violating constitutional rights.” Your behavior and judgment during this incident was abysmal. Your actions were unprofessional and your conduct was unbecoming for an officer....

You are hereby reprimanded. Your actions have shown an alarming lack of judgment, character, and professionalism. Your behavior during these incidents has brought discredit upon your unit, and the United States Air Force...Your conduct raises serious questions about your fitness...and I am compelled to question your ability to continue to serve in the military. I must warn you that any reoccurrence of this behavior or any similar displays of appalling judgment can only jeopardize your career....

Your future conduct will be closely scrutinized, as you have identified yourself as someone requiring close supervision. Harsher measures may be taken if your behavior does not improve immediately...this could include...Court-Martial, or ultimately discharge. Be assured that I will react strongly to any future misbehavior on your part.” (MEMORANDUM FOR MAJOR RICHARD L. RYNEARSON – SUBJECT: Letter of Reprimand, USAF, October 27, 2009)

Five months after this reprimand, Ryneason was disciplined for an unwarranted display of anger and poor judgment:

“I have concluded, based on interviews with (Ryneason) and witnesses, that on 12 Mar 2010 your conduct was unprofessional and prejudicial to good order and discipline. You lost your temper...and...used poor judgement in voicing your displeasure in front of your students while airborne...(and)...once on the ground, you engaged in a heated phone conversation with the...crew within earshot of students...You are hereby counseled...you created a situation that forces me to question your judgment. Your conduct was inappropriate and it was a poor example of...how officers should resolve their disagreements.” (MEMORANDUM FOR MAJOR RICHARD L. RYNEARSON – Subject: Letter of Counseling, USAF, 17 March 2010,)

Seven months after his disciplinary letter for unacceptable anger and poor judgment, once again Rynearson was officially reprimanded, this time for disobeying orders from superior officers and violating a lawful order:

“On 23 September 2011, I gave you a written order to fly in support of a certain classified objective...Your failure to obey a lawful order is in violation of Article 92, Uniform Code of Military Justice...You are hereby reprimanded! You have no authority to decide unilaterally whether to obey a lawful order...you have the duty, both legal and moral, to execute the lawful orders given to you by superior officers...the seriousness of this matter, together with the poor judgment displayed by you on this occasion, compels me to caution you that recurrence of his type of behavior can jeopardize your career.” (MEMORANDUM FOR MAJOR RICHARD LEE RYNEARSON – SUBJECT: Letter of Reprimand, USAF, 26 Oct 2011)

Less than two months after receiving this latest known to me reprimand, Rynearson was deemed a security risk and his clearance to classified information and access to all restricted areas was revoked:

“You are hereby notified that a security determination has been made to suspend your access to classified information and unescorted entry into all restricted areas. This action is being taken because you failed to obey a lawful order, forcing me to question your motives and ability to protect classified information...a Security Information File will be established.” (MEMORANDUM FOR RICHARD LEE RYNEARSON, Maj., 04, USAF – SUBJECT: Notification of Suspension of Access, USAF, 14 November 2011)

Rynearson was also arrested on March 18, 2010 for not cooperating at a routine stop by US Border Patrol. He took his case all the way to the US Fifth Circuit Court of Appeals, where on February 26, 2015, he lost a 2-1 ruling that the routine US Border Patrol stop was legal.

Above a full color photograph of a tapeworm hugging the walls of a human colon on his web blog “PickYourBattles.net,” Rynearson went after the two federal judges who ruled against him, US Fifth Circuit Court of Appeals Judges Thomas Reavley and Leslie Southwick:

“I have killed many foreign enemies overseas who were far better men than Judges Reavley and Southwick. I mean that with the utmost sincerity...turncoat cowards Reavley and Southwick attack America from the inside like tapeworms in the bowels of our once healthy nation that is now malnourished, dying, and beyond the ability of medical science. Parasitic domestic enemies like Judges Leslie Southwick and Thomas Reavley worm around in the corpse that they killed from the interior, and are far more difficult threat to defeat than Al Qaeda or the Iraqi Republican Guard...While they seem like they are a part of ourselves, they are most certainly not, and they are very difficult to remove. They do great damage to America...There isn’t enough tar or feathers in this world to sufficiently coat those two worthless deserters.” (“Upholding our Constitutional Rights Too Unorthodox for Supreme Court of the United States,” PickYourBattles.net, Monday, March 21, 2016)

After his arrests by law enforcement, on July 24, 2011, Ryneerson created the Veterans Against Police Abuse and other sites and pages that started his vendetta against law enforcement and the legal system. (Veterans Against Police Abuse Facebook page)

Ryneerson's "Spy Car/Anti Cop Car"

After his several interactions with and arrests by law enforcement officers, Ryneerson became obsessed with recording interactions with police and protecting himself from their perceived harm. On a You Tube posted video, Ryneerson proceeds to boast about modifying his car with bullet-proof windows and body armor, electrified door handles, smoke screens, numerous cameras, recording devices, flashing strobes, sirens, and a public address system.

The video also demonstrates the type of bullet-proof glass that he installed on his car sustaining point-blank shots from an AK-47 assault rifle. ("Spy Car Protects Against Unscrupulous Cops – Meet Rick Ryneerson and his badass Mitsubishi Eclipse," COP BLOCK.ORG – Badges Don't Grant Extra Rights – Veterans Against Police Abuse, You Tube, July 24, 2012.)

Gun rights advocates and law enforcement officers' concerns and reactions to Ryneerson's "spy car" ranged from amusement to alarm, as gauged from comments from the web blog site "GLOCK TALK – The Leading Firearms Forum" responding to the blog site's "COP TALK" forum on July 31, 2012, of which a member had posted the You Tube video where Ryneerson shows off the features of his car under the title "Spy Car/Anti Cop Car."

"Thought you guys might want to see this (video of Ryneerson's "spy car/anti cop car") ...something tells me this won't end well with him. I wonder what his previous arrests were for. He sure is ticked off though. Electric shocking door handles? Wow...is that even legal?" ("Spy Car/Anti Cop Car," GLOCK TALK - COP TALK, July 31, 2012, Post #1)

"Yikes...this guy has some...issues." ("Spy Car/Anti Cop Car," GLOCK TALK - COP TALK, July 31, 2012, Post #3)

"Flashing strobes, police siren and smoke screen on an armored personal car? Does anyone else just hear "whacker" or "gearing up for a massacre?" ("Spy Car/Anti Cop Car," GLOCK TALK - COP TALK, July 31, 2012, Post #18)

"Just having your smoke screen and sirens (on your car) is illegal where I work. You might want to check your local laws before telling us you don't break them..." ("Spy Car/Anti Cop Car," GLOCK TALK - COP TALK, July 31, 2012, Post #62)

Justification for Request of Immediate Surrender of Weapons

I am truly frightened for my physical safety – and life – from Richard Lee Ryneerson III.

As I have outlined with official and public documents, comments and observations, Ryneerson has a demonstrated record of anger, aggressive behavior and abysmal judgment; unrepentant bravado for killing people; a tormenting and harassing disregard of violating the wishes and feelings of people; dismissiveness and disdain of authority; and protracted disrespect and disdain for our courts and law enforcement.

On the issue of disrespect and disdain for law enforcement, Ryneerson's "spy car/anti-cop car" alone makes me – as it should any rational law enforcement officer – pause with alarm and, both figuratively and literally, shock or worse.

Ryneerson has gone to extraordinary, and perhaps illegal, lengths of planning, designing and expenses – as well as publicly bragging about – creating a car with sirens, lights and a PA system that could be used to impersonate an official law enforcement vehicle, and worse, building a bullet-proofed, smoke screened, mobile security cocoon whose sole function is designed and engineered to evade, resist arrest, avoid capture and to survive a firearms assault.

If any of those events happen, hopefully his vehicle is the only thing that is impacted.

However, it is his vehicle's electrified door handles that patently demonstrates a premeditated and sociopathic intent that has only one offensive, use of force function – to intentionally cause pain, injury or worse for the person who may touch the door handle.

If Ryneerson will go to these astonishing and bizarre lengths to protect himself from his obsessive perception of being oppressed and targeted by armed, professional law enforcement, how am I, as an unarmed private citizen, supposed to imagine and react to what he might have in store for me?

Definitely preserve those points." ("Spy Car/Anti Cop Car," GLOCK TALK – COP TALK, Post #122)*

Provocative pro-gun, tyrannical government rhetoric

Rynearson goes beyond an average, law abiding gun owner, writing bellicose, rabble-rousing calls to arm and the use of weapons, as well as comments supporting and advocating for the total concealment of weapons without permits on his PickYourBattles.Net web blog and provocative comments and pro-gun memes on his Martial Matters Facebook page.

“Those afraid of tyranny of government...(I) have the...remedy. Arm yourself and protect yourself!...If you want to be free, arm yourself! If you want to remain free, arm yourself!” (“Arguments From Fascist Gun Grabbers Are Complete Bullshit,” PickYourBattles.Net, Tuesday, June 21, 2016)

“...(it is) undeniable that it is a top priority of the government to disarm the American people. This government has no respect for the rights of Americans, and it is intent...to make you as defenseless and vulnerable as it pleases...what a blood-soaked tragedy.” (“And You Thought Disarming Americans Couldn’t Happen?” PickYourBattles.Net, Tuesday, October 20, 2015)

Rynearson posted a photo of Adolf Hitler using his quotes to support his view that there is a *“tyranny of government...to disarm the American people...”* (Adolf Hitler): *“To conquer a nation, first disarm its citizens...The most foolish mistake that we could possibly make would be to allow the subject races to possess arms...Indeed, I would go so far as to say that the supply of arms to the underdogs is a sine qua non for the overthrow of any sovereignty. So let’s not have any native militia or native police.”* (“The SCOTUS – The Loophole to the Amendment Provision,” PickYourBattles.net, Monday, December 7, 2015; Martial Matters Facebook Page, December 7, 2015; “Arguments From Fascist Gun Grabbers Are Complete Bullshit,” PickYourBattles.Net, Tuesday, June 21, 2016; “And You Thought Disarming Americans Couldn’t Happen?,” PickYourBattles.Net, Tuesday, October 20, 2015)

In responding to news headline that reported *“In a victory for gun control advocates, a federal court said...(that) people do not have the right to carry concealed weapons in public under the 2nd Amendment,”* Rynearson responded: *“More parasites in robes spreading fascism through the third branch of government, ignoring our Constitution (sic) and serving their masters who are not the American people.”* (Martial Matters Facebook page, June 10, 2016)

Rynearson praises Missouri and other states that *“...let people carry concealed weapons without a permit anywhere they can carry guns openly, something that doesn’t require a permit...”* (Martial Matters Facebook page, April 30, 2016)

Everyone should have grave concerns about anyone who boasts about “killing people”

I am terribly distressed and frightened by Ryneerson’s stunningly unrepentant and repeated bravado about killing people, of which even the US Air Force officially reprimanded and disciplined him for his “...*disturbing (and) boastful taunting...of...statements “(I am) military...and (I have) killed people”* and Ryneerson’s own impetuous, provocative comment “*I have killed many foreign enemies overseas who were far better men than Judges Reavley and Southwick.*” (MEMORANDUM FOR MAJOR RICHARD L. RYNEARSON – SUBJECT: Letter of Reprimand, USAF, October 27, 2009; “Upholding our Constitutional Rights Too Unorthodox for Supreme Court of the United States,” PickYourBattles.net, Monday, March 21, 2016)

I’m proud to come from a military family of World War II, Vietnam and Gulf War veterans, and Ryneerson’s unremorseful, disturbing boasting sends a chill up my spine and spikes fear into my psyche.

Throughout my life I’ve talked to the veterans in my family – along with dozens of my friends, associates and acquaintances who are also war theater, on-the-ground battlefield tested veterans – and I cannot recall a single one of them – NOT ONE – ever bragging or boasting about ANY of their battlefield encounters of which involved killing people.

Case in point. It was always a memorable and exciting time for me when my uncle – a Bronze Star, Purple Heart, US Army infantry sergeant who was killed during his fourth tour of the Vietnam War the day before my 14th birthday – would make that rare visit to see my parents and stay with us, because as his adoring adolescent nephew, I was on edge to hear all about my war hero uncle’s experiences on the battlefield and stories about his heroism.

My war-weary uncle would arrive in his uniform decorated with medals and indulge me with some stories, but would share precious little detail – if anything at all. More often than not he would simply say to me and my family: “you do what you have to do to stay alive.”

However, one moment is forever seared in my memory.

One night as we were all eating dinner at the family table, being the precocious little kid that I was, I began insistently probing and asking my uncle questions for more detail about his war experiences, when suddenly he burst out “ENOUGH!”

My uncle saw that we were all taken aback and he quickly apologized. My parents rightfully admonished me for my behavior and told me to apologize, but before I could say that I was sorry to my uncle, he suddenly and forcefully pushed his chair away from the table, bowed his head and stared down at his lap as he slowly kneaded his hands.

We all paused in frozen silence for what felt like an eternity.

When my uncle finally looked up, he took off his glasses and used his napkin to wipe the tears from his eyes. He pulled his chair back to the table, put his arm around my shoulder, and simply said:

“I just wish the nightmares would go away.”

I wish that my nightmares caused by and about Rynearson would go away. Unlike my late uncle and every other veteran that I know who wore our nation’s uniforms and never bragged about killing people, when I researched about Rynearson’s callous boasting about killing people; his bullying and lack of empathy for other peoples’ wishes and feelings; disdain for law enforcement and the courts; his bullet-proofed “spy car/anti-cop car” and provocative bravado about using guns to solve perceived injustices and defend against the “tyranny of government,” all of this disturbing information about him has engulfed me over the past month with far too many stressful, anxious days, sleepless nights and upsetting nightmares.

After one veteran’s futile and exasperating experience of dealing with Rynearson, he warned that Rynearson was “...**frightening. To those he’s calling out by name, keep checking your six.**” (“Decline of Baseops.net (a.k.a. Summation for Petition for a Permanent Order for Protection of Harassment and Stalking and Request for an Immediate Surrender of Weapons against Richard Lee Rynearson III/a.k.a. Rick Rynearson/Richard Lee

I have lived on Bainbridge Island for nearly two decades and it is here where I hope to be able to spend the rest of my life. I may have been born in Moses Lake, Washington, but Bainbridge Island is my home, a community in which I have embraced and contributed to with passionate hard work, much love and, wonderfully, a community that has hugged me back and welcomed me with friendships, warmth and appreciation.

However, the quality and safety of my life moving forward will not be possible as demonstrated in the ample evidence presented in this statement and supporting documentation – along with my previously submitted March 10, 2017 statement and supporting documentation – revealing Richard Lee Rynearson III’s years-long record of compulsive cyber stalking, internet trolling and harassment; unrepentant boasting for killing people; an unnerving documentation of anger, aggressive behavior and abysmal judgment; contempt of laws and law enforcement; disdain and disregard of our courts, authority and the feelings and wishes of people; provocative and proactive passion for the unlimited use and unpermitted concealment of firearms to protect against “the tyranny of government;” and his premeditated action for the use of force to intentionally cause harm.

To provide for the hope and security to move forward and to live my life completely free of the fear, apprehension and anxiety caused and created from the oppressive and threatening impact of Richard Lee Rynearson III's demonstrated cyberstalking, obsessive harassment and potential physical harm, and that to feel safe, secure and fully shielded from any possible future contact with him physically or virtually will only be possible by the court's positive affirmation of total protection from him in all manners legally possible, therefore I am hereby seeking relief from the court by the granting of a Permanent Order for Protection of Harassment and Stalking and an Immediate Surrender of Weapons.

I also hereby request to amend the Temporary Protection Order/place into the Permanent Order an increase of the Stay Away prohibition distance for the respondent from 100 feet to the more typical request of 500 feet or greater.
